# 4. Your Rights

#### 6. How Do We Use Your Data?

- 6.1 All personal data is processed and stored securely, for no longer than is necessary in light of the reason(s) for which it was first collected. We will comply with our obligations and safeguard your rights under GDPR at all times. For more details on security see section 7, below.
- 6.2 CDT/Career Decisions Ireland is committed to ensuring that all employees, associates, contractors and data processors comply with the Data Protection Acts regarding:

We will not, however, send you any unsolicited marketing or spam and will take all reasonable steps to ensure that We fully protect your rights and comply with Our obligations under GDPR and, where relevant the Privacy and Electronic Communications (EC Directive) Regulations 2003.
- 6.5 You have the right to withdraw your consent to us using your personal data at any time, and to request that We delete it.
- 6.6 We do not keep your personal data for any longer than is necessary in light of the reason(s) for which it was first collected. Data will therefore be retained for the following periods (or its retention will be determined on the following bases):

How and Where Do We Store Your Data?

6.7 We only keep your personal data for as long as we need to in order to use it

as described above in section 6, and/or for as long as we have your permission to keep it.

- 6.7.1 Some or all of your data may be stored outside of the European Economic Area ("the EEA") (The EEA consists of all EU member states, plus Norway, Iceland, and Liechtenstein). You are deemed to accept and agree to this by using www.coachdeveloptransform.com and submitting information to us. If we do store data outside the EEA, We will take all reasonable steps to ensure that your data is treated as safely and securely as it would be within Ireland and under the GDPR.
